ASSIGNOR does hereby sell, assign, and transfer to ASSIGNEE the entire right, title and interest in and to the Trademarks, including the corresponding applications owned by ASSIGNOR for such Trademarks, and that part of the business of ASSIGNOR connected with the use of and symbolized by said Trademarks, including the subject matter of any and all claims that may be obtained in every such Trademark and all rights to sue and to recover thereon.

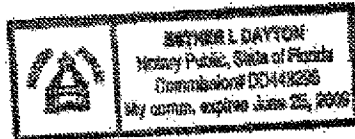
