RELEASE AND REASSIGNMENT

DVB BANK AMERICA N.V., a Netherlands Antilles company acting in its capacity as Facility and Security Agent (the "Agent") under the Loan Agreement, dated as of April 29, 2005, among Paul Gauguin Shipping Limited as Borrower (the "Borrower"), Paul Gauguin Holding Ltd. (the "Parent"), Grand Circle LLC and Grand Circle River Cruise Lines LLC as Guarantors, the various lenders referred to therein and the Agent, hereby:

- (i) releases the Borrower from any and all obligations to the Agent under the Assignment of Earnings dated May 10, 2005 made by the Borrower in favor of the Agent respecting the earnings of the Bahamian flag vessel PAUL GAUGUIN, Official Number 8000741 (the "Vessel"), and reassigns, without recourse, to the Borrower all of the Agent's right, title and interest in and to said earnings;
- (ii) releases the Borrower from any and all obligations to the Agent under the Assignment of Insurances dated May 10, 2005 made by the Borrower in favor of the Agent respecting the insurances of the Vessel, and reassigns, without recourse, to the Borrower all of the Agent's right, title and interest in and to said insurances;
- (iii) releases the Parent from any and all obligations to the Agent under the Share Mortgage dated May 10, 2005 wherein the Parent mortgaged all the shares of the Borrower in favor of the Agent, and reassigns and transfers, without recourse, to the Parent all of the Agent's right, title and interest in and to said shares; and
- (iv) releases the Borrower from any and all obligations to the Agent under the Security Agreement dated as of May 10, 2005 made by the Borrower in favor of the Agent, providing, among other things, for an assignment of the Borrower's word mark "PAUL GAUGUIN", United States Patent and Trademark Office serial number 78604702, which assignment was filed with the United States Patent and Trademark Office on June 15, 2005, and reassigns and transfers, without recourse, to the Borrower all of the Agent's right, title and interest in and to said word mark.
