**TRADEMARK ASSIGNMENT**

WHEREAS, Eco-Block, LLC, a Georgia limited liability company (hereinafter "Assignor"), is the owner of the trademarks and related registrations therefor specified in Exhibit A, attached hereto (collectively, "Trademarks");

The right, title and interest is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this Assignment not been made.

Assignor further agrees that it will execute, verify, acknowledge and deliver all reasonably required further documents, including any instruments of transfer and other recordable documents, and perform such other acts as Assignee or its successor and assigns lawfully and reasonably may request from time to time, to perfect and vest title in the Trademarks in Assignee or its successors and assigns.

Assignor will deliver, within 30 days following the date of execution of this Assignment, copies of all prosecution files relating to the registrations and applications for registration of the Trademarks to counsel for Assignee, excluding attorney-client privileged communications. In exchange for reimbursement of its out-of-pocket costs, Assignor will provide access to all non-privileged documents and witnesses under its control in connection with any enforcement activities of Assignee or its successors and assigns in connection with the Trademarks.
