Further, ASSIGNOR hereby agrees that ASSIGNEE shall have the right to record this instrument of assignment with the United States Patent and Trademark Office and any and all appropriate foreign trademark authorities so as to establish ASSIGNEE as owner of record of the Marks and Applications. In the event that this document is found unacceptable to transfer the rights from ASSIGNOR to ASSIGNEE or to make such transfer of record in any jurisdiction, ASSIGNOR agrees to execute any documents and take whatever other actions required to permit ASSIGNEE to perfect its rights in the trademarks and applications assigned hereunder at no



additional cost to ASSIGNEE.
