ASSIGNMENT OF TRADEMARK

The following Assignment of Trademark (the "Assignment") is executed this 17th day of June, 2008, by and between Tiff's Treats Holdings, Inc., a Texas company having its principal place of business at 1806 Nueces, Austin, Travis County, Texas 78701 (the "Company"), and Tiff's Treats GP, LLC., a Texas limited liability company having its principal place of business at 1806 Nueces, Austin, Texas 78701 (the "LLC").

WHEREAS, the LLC is the current owner of the trademark Tiff's Treats (and Design), which was registered to Leon Chen by the United States Patent and Trademark Office on April 18, 2006, registration number 3083436; and conveyed by Chen to the Company with the assignment instrument recorded in the USPTO at real/fram: 003374/0820 on August 22, 2006;

WHEREAS, the Company has become the owner of all of the membership interests of the LLC;

WHEREAS, the LLC desires to transfer ownership of the Trademark to the Company and the Company desires to receive ownership of the Trademark.

NOW THEREFORE, in exchange for the mutual covenants made herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Company and the LLC hereby agree as follows:

1. Trademark Ownership. The LLC does hereby permanently, completely and exclusively assign, transfer and convey unto the Company all of the LLC's currently existing and future rights, title and interest in and to the Trademark, including all goodwill associated therewith.

2. Transfer by the Company. Nothing in this Assignment shall limit the power of the Company to transfer the Trademark, by whatever legal means, to another party.

3. Miscellaneous. This Assignment shall be construed according to the laws of the State of Texas, without regard to its rules governing conflict of laws. This Assignment contains the full, final and exclusive statement of the agreement between the parties with respect to the transfer of rights set out herein.
