And for the consideration aforesaid, ASSIGNOR agrees that it will communicate to ASSIGNEE or the representatives thereof any facts known to ASSIGNOR respecting THE MARK, and will, upon request, but at ASSIGNEE'S expense, testify in any legal proceedings, sign all lawful papers, execute all applications and/or registrations and/or renewal applications, make all rightful oaths, and generally do all other and further lawful acts, deemed necessary or expedient by said ASSIGNEE or by counsel for said ASSIGNEE, to assist or enable said ASSIGNEE to obtain and enforce full benefits from the rights and interests herein assigned.
