Intellectual Property Security Agreement

This Intellectual Property Security Agreement is entered into as of September 18, 2009, between Currensee, Inc., a Delaware corporation (the "Grantor") and North Bridge Venture Partners VI, L.P. (the "Secured Party"). Capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Security Agreement as defined below.

RECITALS

A. The Secured Party has agreed to make certain advances of money and to extend certain financial accommodations to Grantor (the "Loan") in the amounts and manner set forth in the Note Purchase Agreement of even date herewith by and among the Grantor and the Secured Party (the "Purchase Agreement"). The Secured Party is willing to make the Loan to Grantor, but only upon the condition, among others, that Grantor shall grant to the Secured Party a security interest in, among other things, certain copyrights, trademarks and patents to secure the obligations of Grantor under that certain Security Agreement of even date herewith by and among the Grantor and the Secured Party, as the same may be amended, modified or supplemented from time to time (the "Security Agreement").

B. Pursuant to the terms of the Security Agreement, Grantor has granted to the Secured Party a security interest in all of Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of its obligations under the Security Agreement and the Purchase Agreement, Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

To secure its obligations under the Security Agreement and the Purchase Agreement, Grantor grants and pledges to the Secured Party a security interest in all of Grantor's right, title and interest in, to and under its intellectual property Collateral (including without limitation those copyrights, patents and trademarks listed on Schedules A, B and C hereto), together with all goodwill of the business symbolized by the trademarks, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof, and all proceeds of each of the foregoing (including, without limitation, all license royalties and proceeds of infringement suits).

This security interest is granted in conjunction with the security interest granted to the Secured Party under the Security Agreement. The rights and remedies of the Secured Party with respect to the security interest granted hereby are in addition to those set forth in the Security Agreement and the other Transaction Documents (as defined in the Purchase Agreement), and those which are now or hereafter available to the Secured Party as a matter of law or equity.

Each right, power and remedy of the Secured Party provided herein or in the Security Agreement or any of the Transaction Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by the Secured Party of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Security Agreement or any of the other Transaction Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, of any or all other rights, powers or remedies.
