RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "**Release**"), dated as of September 25, 2009, is made by **BANK OF AMERICA, N.A.**, as agent (successor by merger to LaSalle National Bank National Association), a national banking association ("**Bank**").

WHEREAS, pursuant to that certain Trademark Security Agreement (the "**Trademark Security Agreement**"), dated on or about October 29, 1996, Ocenco Incorporated, a Pennsylvania corporation (the "**Grantor**") granted security interests in the Trademark Collateral (as such term is defined in the Trademark Security Agreement), including, without limitation, the intellectual property listed on Annex I attached hereto, to Bank to secure the repayment of certain obligations to Bank;

WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on October 29, 1996 at Reel/Frame No. 1494/0028; and

WHEREAS, pursuant to that certain Consolidated, Amended and Restated Loan Agreement, dated on or about September 25 2009 (the "**Loan Agreement**"; capitalized terms used in this Release and not herein defined shall have the meanings set forth in the Loan Agreement), by and among the Grantor, Interspiro, Inc. and Bank, Bank released and terminated its security interests in, among other things, the Trademark Collateral.

NOW THEREFORE, Bank hereby terminates the Trademark Security Agreement and **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Trademark Collateral, granted pursuant to the Trademark Security Agreement and the Bank hereby reassigns any and all such right, title and interest (if any) that the Bank may have in the Trademark Collateral to the Grantor.


