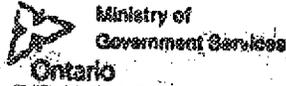

2. Dividends

The holders of the Common Shares shall be entitled to receive dividends as and when the directors shall in their discretion declare dividends on the Common Shares and pay the same.

3. Dissolution

The holders of the Common Shares shall be entitled to receive the remaining property of the Corporation in the event of any liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary, or other distribution of assets of the Corporation among its shareholders for the purpose of winding-up its affairs.

11. The issue, transfer or ownership of shares is/is not restricted and the restrictions (if any) are as follows:

- C. subject to the provisions of the Business Corporations Act (Ontario) as amended or re-enacted from time to time, give a guarantee on behalf of the Corporation to secure performance of an obligation of any person;
- D. mortgage, hypothecate, pledge or otherwise create a security interest in all or any property of the Corporation owned or subsequently acquired, to secure any obligation of the Corporation; and
- E. by resolution, delegate any or all such powers to a director, a committee of directors or an officer of the Corporation.

13. The corporation has complied with subsection 180(3) of the *Business Corporations Act*.

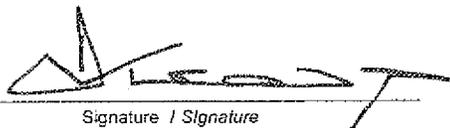
