RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Jill Holdings LLC, Jill Acquisition LLC and J. Jill Sourcing LLC, all Delaware limited liability companies ("Debtors"), with their chief executive office at 4 Batterymarch Park, Quincy, Massachusetts 02169, granted a security interest in and lien upon certain trademarks and related rights to The CIT Group/Business Credit, Inc., as Administrative Agent and Collateral Agent ("Secured Party") as set forth in that Trademark Security Agreement, dated July 2, 2009, by Debtors in favor of Secured Party (the "Security Agreement");

WHEREAS, an executed copy of the Security Agreement was recorded in the United States Patent and Trademark Office on July 2, 2009 at Reel 4016 Frame 0680;

WHEREAS, Debtors have requested that Secured Party release and reassign its interest in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby (the "Marks");


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. (i) terminates the Security Agreement as it pertains to the Marks, (ii) terminates, cancels and releases any and all liens and security interests it has against the Marks, and (iii) reassigns to Debtors any right, title and interest it may have in, to and under the Marks, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtors to Secured Party pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
