- (1) **PILKINGTON GROUP LIMITED** (formerly Pilkington Plc), a company incorporated in England and Wales under company number 41495 whose registered office is at Prescott Road, St Helens, Merseyside, WA10 3TT ("Assignor"); and
- (2) **CORNING INCORPORATED**, a company incorporated under the laws of New York State whose principal place of business is at One Riverfront Plaza, Corning, NY 14831 ("Assignee").

BACKGROUND

- A By way of a sale and purchase agreement dated on or around the date hereof ("Sale and Purchase Agreement") Corning SAS has agreed to purchase the x-ray and nuclear radiation shielding glass businesses and assets of Pilkington Special Glass Limited and the assets of the x-ray radiation shielding glass business of Pilkington Special Glass (Shanghai) Limited ("Vendors").
- B Under the terms of the Sale and Purchase Agreement, the Vendors have agreed to procure the assignment of the registered trade marks and trade mark applications set out in Part A of the schedule ("UK Business Trade Marks") and Part B of the schedule ("China Business Trade Marks") (together "Trade Marks") to the Assignee on the terms and conditions set out below.

IT IS HEREBY AGREED as follows:

1. DEFINITIONS

Terms defined in the Sale and Purchase Agreement shall have the same meaning in this Assignment.

2. ASSIGNMENT

- 2.1 In consideration of the sum of one pound (£1) now paid by the Assignee to the Assignor, (the receipt of which is hereby acknowledged), the Assignor hereby assigns to the Assignee:

2.1.1 upon UK Completion, the UK Business Trade Marks; and

2.1.2 upon China Completion, the China Business Trade Marks.

2.2 The Assignor now confirms to the Assignee that the assignment in clause 2.1 includes (to the extent that the same vests in the Assignor), any goodwill relating to the Trade Marks together with any right to sue for damages and any other remedies in respect of any past infringement of the whole or any part of the Trade Marks.

3. COUNTERPARTS

This Assignment may be executed by the parties in any number of counterparts and on separate counterparts, each of which shall constitute an original, but all the counterparts together shall constitute one and the same instrument.

4. GOVERNING LAW AND JURISDICTION

4.1 This Assignment and any matter arising from or in connection with it shall be governed by and construed in accordance with English law.

4.2 Each party irrevocably agrees to submit to the exclusive jurisdiction of the English courts over any claim or matter arising from or in connection with this Assignment.

5. FURTHER ASSURANCE

Without prejudice and in addition to the other provisions of this Assignment, each party shall, so far as it is reasonably able, from time to time and at the requesting party's expense, do (or procure to be done) all such other things and/or execute and deliver (or procure to be executed and delivered) all such other documents as may be reasonably required for the purpose of giving full effect to this Assignment.
