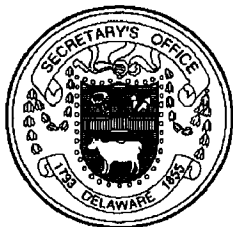

a Delaware corporation

(Pursuant to Section 252 of the General Corporation Law of the State of Delaware)

Pursuant to Section 252(c) of the General Corporation Law of the State of Delaware (the "DGCL"), Vizada, Inc., a Delaware corporation (the "Company"), in connection with the merger of MindSparX, Inc. a Maryland corporation ("MindSparX"), with and into the Company (the "Merger"), hereby certifies as follows:

FIRST: The name and state of incorporation of each of the constituent corporations to the Merger (the "Constituent Corporations") are as follows:

MindSparX, Inc.	Maryland

SECOND: An Agreement and Plan of Merger, dated as of October 3, 2007, by and between the Company and MindSparX (the "Merger Agreement"), setting forth the terms and conditions of the Merger, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with Section 252(c) of the DGCL.

THIRD: Vizada, Inc. shall be the surviving corporation of the Merger (the "Surviving Corporation"). The name of the Surviving Corporation is Vizada, Inc.

FOURTH: The certificate of incorporation of the Surviving Corporation shall be the certificate of incorporation of the Surviving Corporation.

FIFTH: An executed copy of the Merger Agreement is on file at the office of the Surviving Corporation located at 1101 Wootton Parkway, Suite 1000, Rockville, Maryland 20852 USA.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either of the Constituent Corporations.

SEVENTH: The authorized capital stock of MindSparX preceding the Merger is 1,500,000 shares of common stock, par value \$0.001 per share.

EIGHTH: This Certificate of Merger shall be effective on the date and at the time it is filed with the Secretary of State of the State of Delaware.
