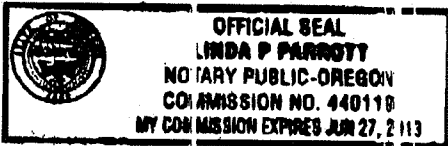
SEE ATTACHED SCHEDULE A
