ASSIGNMENT OF SERVICE MARK

Assignor does hereby further covenant and agree with Assignee to execute and deliver such other and further instruments and take such other and further actions as may be reasonably necessary or appropriate to transfer said mark, claims for damages by reason of past infringement, and right to sue and collect therefor to the Assignee.
