RELEASE OF SECURITY INTEREST IN TRADEMARK

SOURCE INTERLINK MAGAZINES, LLC ("Debtor") granted a security interest in the trademark set forth on Schedule A (the "Mark") to CITICORP NORTH AMERICA, INC. 2. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
