TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("*Assignment*") is made as of November 19, 2009 (the "*Effective Date*"), by and between VISTA EQUITY PARTNERS, LLC, a Delaware limited liability company, having a principal place of business at 150 California Street, 19th Floor, San Francisco, California, 94111 ("*Assignor*"), and ACCERO, INC., a Delaware corporation, having a principal place of business at 17040 Pilkington Road, Suite 300, Lake Oswego, Oregon, 97035 ("*Assignee*"). Assignor desires to assign and transfer to the Assignee, and Assignee desires to acquire, all of Assignor's right, title and interest in and to the Mark, the Goodwill, along with the corresponding registration.

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignor hereby conveys, transfers, assigns, and delivers to the Assignee all right, title, and interest of Assignor in and to the Mark, together with the: (i) goodwill of the business symbolized by the Mark; (ii) Assignor's entire right, title and interest in and to the USPTO registration of the Mark; (iii) all common law rights to the Mark in the United States and any state thereof; and (iv) all claims for damages by reason of past, present and/or future infringement of the Mark, with the right to sue for, and collect, the same for Assignee's own use and benefit.

2. Assignor does hereby expressly agree that Assignee may singly, and without assistance or consent from Assignor, undertake procedures to record the transfer of the Mark to Assignee in the United States Patent and Trademark Office.

3. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Mark.




