## SECOND LIEN INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT

This SECOND LIEN INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Second Lien IP Security Release*") dated December 10, 2009, is made by CREDIT SUISSE AG (formerly known as CREDIT SUISSE FIRST BOSTON), acting through one or more of its branches or any Affiliate thereof ("*Credit Suisse*"), as collateral agent (the "*Collateral Agent*") for the Secured Parties (as defined in the Second Lien Credit Agreement referred to below) in favor of DATATEL ACQUISITION CORP., DATATEL MERGERSUB, INC. (now known as Datatel, Inc.), DATATEL, INC., DATATEL HOLDINGS, INC., LETATAD, LLC, and LIQUIDMATRIX CORP. (now known as Datatel, Inc.) (collectively, the "*Grantors*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Second Lien Credit Agreement and the Second Lien IP Security Agreement (as defined below).

WHEREAS, Datatel, Inc. (as surviving entity of the Merger), a Virginia corporation, entered into a Second Lien Secured Credit Agreement dated as of April 5, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Second Lien Credit Agreement*"), with Credit Suisse First Boston, as Administrative Agent and Collateral Agent, Wells Fargo Foothill, Inc. as Syndication Agent, and the Lenders party thereto.

WHEREAS, as a condition precedent to the making of Loans by the Lenders under the Second Lien Credit Agreement, each Grantor executed and delivered that certain Second Lien Security Agreement dated April 5, 2005 made by the Grantors to the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Second Lien Security Agreement*").

WHEREAS, under the terms of the Second Lien Security Agreement, the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and executed that certain Intellectual Property Security Agreement dated April 5, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Second Lien IP Security Agreement*") for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

WHEREAS, the Second Lien IP Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on May 5, 2005 at Reel 003157 and Frame 0134 and with the United States Copyright Office on May 20, 2005 in Volume 3525 and Document No. 295.

WHEREAS, the Collateral Agent now desires to release its security interest in and to the Grantors' right, title and interest in and to the Collateral identified in this Second Lien IP Security Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

SECTION 1. Release of Security Interest. The Collateral Agent hereby terminates and releases in its entirety its security interest in and to each Grantor's right, title and interest in and to the Collateral, including the Collateral set forth on Schedules A, B and C hereto, and any right, title or interest of the Collateral Agent in such Collateral shall hereby cease and become void.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Second Lien IP Security Release.


SECTION 3. Governing Law. This Second Lien IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 4. Further Assurance. The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
