**AMENDMENT TO THE ARTICLES OF ORGANIZATION

Article 1 of the Articles of Organization is hereby deleted in its entirety and replaced with the following:


"The name of the limited liability company is Medical Direct Club, LLC."


3. The amendment was duly adopted on September 21, 2009 by the members of the Company.
