Re: Loan and Security Agreement dated as of April 2, 2007 (the "Loan Agreement") among Remet Corporation and the other borrowers named therein (individually and collectively, the "Borrower") and the Lender

Ladies and Gentlemen:

Reference is made to the Loan Agreement described above. Capitalized terms used and not otherwise defined in this letter shall have the meanings herein as set forth in the Loan Agreement.

In connection with the closing of the loan evidenced by the Loan Agreement on April 2, 2007 (the "Closing Date"), Borrower has agreed to deliver the following items:

1. Within thirty (30) days after the Closing Date, the Borrower shall cause the security instrument granted to Royal Bank of Scotland with respect to certain intellectual property, which security instrument was dated September 28, 2001 and was recorded in the United States Patent and Trademark Office, to be discharged of record.
2. Within seven (7) days after the Closing Date, the Borrower shall cause National Westminster Bank ("Nat West") to sign and return to Lender those certain acknowledgments attached to the account notice delivered to Nat West by Lender regarding Lender's floating charge on the account(s) being maintained by Borrower at Nat West.

The delivery of the documents identified above is required to be made as soon as possible, but in any event, not later than the time period identified above with respect to each item.

The Borrower delivers this letter intending to be legally bound and acknowledges that failure to comply with the terms of this letter by the deadlines described above with respect to each item to be delivered, shall constitute an Event of Default under the Loan Agreement.
