TRADEMARK ASSIGNMENT AGREEMENT

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Seller does hereby sell, assign, and transfer to Purchaser all of Seller's rights, title and interest in and to the Trademarks, whether registered or at common law, together with the goodwill of the business associated with the Trademarks, and all right, title and interest in any registrations or pending applications for the Trademarks, including, but not limited to, those listed in the attached Schedule 1 entitled "ASSIGNED TRADEMARK AND SERVICE MARK FILINGS BY COUNTRY". Seller further hereby assigns any and all claims, demands, and causes of action for infringement of the Trademarks, past, present and future, and all of the proceeds from the foregoing, accrued and unpaid and hereafter accruing.

Seller agrees that it will reasonably cooperate with Purchaser and that it will sign and/or deliver to Purchaser all documents reasonably necessary to record this assignment and any prior assignments or other transfers of ownership of the Trademarks in any country of the world.

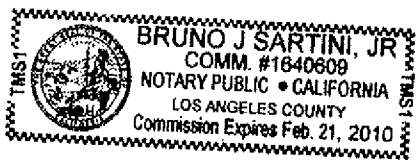
