**ARTICLES OF AMENDMENT TO THE  
 ARTICLES OF INCORPORATION  
 OF**

**SAFETRAC CONTROL SYSTEMS, INC.**

Pursuant to Article 4.02 of the Texas Business Corporation Act, the undersigned corporation (the "Company") does hereby amend its articles of incorporation (the "Articles of Incorporation") as follows:

1. The name of the Company is SafeTrac Control Systems, Inc.
2. The Articles of Incorporation shall be amended as follows:
  - a. Article I of the Articles of Incorporation as filed on June 23, 1995 shall be amended by deleting such article in its entirety and replacing such article with the following article:

**"ARTICLE I**

The name of the Corporation is "SAT Corporation "

3. These articles of amendment to the Articles of Incorporation were adopted by the shareholders of the Company by written consent of the shareholders dated February 24, 1999.
4. At the time of the adoption of this amendment, the Company had outstanding Four Thousand Five Hundred Twenty Four and 40/100 (4,524.40) shares of common stock, par value \$.01 (the "Common Stock"), each of which was entitled to vote on this amendment.
5. By written consent of the shareholders of the Company Four Thousand Five Hundred Twenty Four and 40/10 (4,524.40) shares of Common Stock were voted in favor of such amendment and no (0) shares of Common Stock were voted against the amendment.

THE UNDERSIGNED Company does make these articles, hereby declaring and certifying that this is its act and deed and the facts herein stated are true, and accordingly has hereunto set its hand and seal this 24th day of February, 1999.
