Dear Sirs

Parts Bidco Limited - senior multicurrency term and revolving facilities agreement dated 27 November 2008 made between, amongst others, (1) Parts Bidco Limited as Parent, (2) the company listed in part 1 of schedule 1 thereto as Original Borrower, (3) the company listed in part 1 of schedule 1 thereto as Original Guarantor, (4) The Royal Bank of Scotland plc, Barclays Leveraged Finance and The Governor and Company of the Bank of Ireland as Arrangers, (5) the financial institutions listed in part 2 of schedule 1 thereto as Original Lenders, (6) The Royal Bank of Scotland plc as Agent, (7) The Royal Bank of Scotland plc as Security Agent and (8) Barclays Bank PLC as Issuing Bank as the same may be amended, varied, novated and/or restated from time to time (the "Senior Facilities Agreement").

1. We refer to the Facilities Agreement. This is an Accession Letter. Terms defined in the Senior Facilities Agreement have the same meaning in this Accession Letter unless given a different meaning in this Accession Letter.
2. Each Acceding Company agrees to become an Additional Borrower and an Additional Guarantor and to be bound by the terms of the Senior Facilities Agreement and the other Finance Documents as an Additional Borrower and an Additional Guarantor pursuant to clause 32.2 (*Additional Borrowers*) and clause 32.4 (*Additional Guarantors*) of the Senior Facilities Agreement. Each Acceding Company is a company duly incorporated under the laws of the country set out opposite its name in schedule 1 hereto and is a limited liability company with the registered number set out opposite its name in schedule 1 hereto.
3. Each Acceding Company confirms that its address and fax number for notices in relation to clause 38 (*Notices*) of the Senior Facilities Agreement are those identified with its name below.
4. This Accession Letter and any non-contractual obligations arising out of or in connection with it are governed by English law.
5. This Accession Letter is entered into by deed.

ACCESSION DEED

THIS ACCESSION DEED is made on

BETWEEN

- (1) EACH COMPANY LISTED IN SCHEDULE 1 (each an "Acceding Company" and together the "Acceding Companies");
- (2) PARTS BIDCO LIMITED (the "Parent"); and
- (3) THE ROYAL BANK OF SCOTLAND PLC (as Security Agent for the Secured Parties (as defined below)) (the "Security Agent").

BACKGROUND

This Accession Deed is supplemental to a debenture dated 27 November 2008 and made between (1) the Charging Companies named in schedule 1 to it and (2) the Security Agent (the "Debenture").

IT IS AGREED:

1. DEFINITIONS AND INTERPRETATION

(a) **Definitions**

Terms defined in, or construed for the purposes of, the Debenture have the same meanings when used in this Accession Deed including the recital to this Accession Deed (unless otherwise defined in this Accession Deed).

(b) **Construction**

Clause 1.2 (*Interpretation*) of the Debenture applies with any necessary changes to this Accession Deed as if it were set out in full in this Accession Deed.

2. ACCESSION OF THE ACCEDING COMPANIES

(a) **Accession**

Each Acceding Company:

- (i) unconditionally and irrevocably undertakes to and agrees with the Security Agent to observe and be bound by the Debenture; and
- (ii) creates and grants at the date of this Deed the charges, mortgages, assignments and other security which are stated to be created or granted by the Debenture,

as if it had been an original party to the Debenture as a Charging Company.

(b) **Covenant to pay**

Without prejudice to the generality of clause 2(a) (*Accession*), each Acceding Company (jointly and severally with the other Charging Companies and each other Acceding Company), covenants in the terms set out in clause 2 of the Debenture (*Covenant to pay and default interest*).

(c) **Charge and assignment**

Without prejudice to the generality of clause 2(a) (*Accession*), each Acceding Company with full title guarantee (save in respect of any property and assets in Scotland or subject to Scots law), charges and assigns (and agrees to charge and assign) to the Security Agent for the payment and discharge of the Secured Obligations, all its right, title and interest in and to the property, assets and undertaking owned by it or in which it has an interest, on the terms set out in clauses 3 (*Grant of security*), 4 (*Fixed security*) and 5 (*Floating charge*) of the Debenture including (without limiting the generality of the foregoing):

- (i) by way of first legal mortgage all the freehold and leasehold Real Property (if any) vested in or charged to the Acceding Company (including, without limitation, the property specified against its name in part 1 of schedule 2 (*Details of Security Assets owned by the Acceding Companies*) (if any and excluding any Real Property situated in Scotland));
- (ii) by way of first fixed charge:
 - (A) all the Charged Securities (including, without limitation, those specified against its name in part 2 of schedule 2 (*Details of Security Assets owned by the Acceding Companies*) (if any)); together with
 - (B) all Related Rights from time to time accruing to them;
- (iii) by way of first fixed charge each of its Cash Collateral and Collection Accounts and its other accounts with any bank or financial institution at any time (including, without limitation, those specified against its name in part 3 of schedule 2 (*Details of Security Assets owned by the Acceding Companies*) (if any) and all monies at any time standing to the credit of such accounts;
- (iv) by way of first fixed charge all Intellectual Property (including, without limitation, the Intellectual Property specified against its name in part 4 of schedule 2 (*Details of Security Assets owned by the Acceding Companies*) (if any));
