RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is given January 22, 2010, by DEUTSCHE BANK AG NEW YORK BRANCH, as agent for the Secured Parties (as defined in the Credit Agreement referred to below) (in such capacity, the "Administrative Agent"), to JT SPORTS LLC, as a Grantor (Grantor or Grantors as defined in the Credit Agreement below), as follows:

WHEREAS, pursuant to the Credit Agreement, dated as of January 24, 2005 (as the same may be amended, restated, supplemented and/or otherwise modified from time to time, the "Credit Agreement"), among Jarden Corporation (the "Borrower"), the Lenders and L/C Issuers party thereto and the Administrative Agent, the Lenders and the L/C Issuers have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, the Grantor is party to a Pledge and Security Agreement, dated as of January 24, 2005, in favor of the Administrative Agent (as the same may be amended, restated, supplemented and/or otherwise modified from time to time, the "Security Agreement") pursuant to which the Grantors are required to execute and deliver a Trademark Security Agreement; and

WHEREAS, on December 7, 2007, the Grantors and the Administrative Agent entered into a Trademark Security Agreement (the "TSA"); and

WHEREAS, pursuant to the TSA, the Grantors assigned, granted, conveyed, pledged, hypothecated and transferred to the Administrative Agent, among other collateral, a continuing security interest in each Grantor's right, title and interest, including goodwill, in, to and under the trademarks listed in Schedule I of the TSA; and

WHEREAS, the Administrative Agent wishes to release its security interests in those certain trademarks, as further identified on Schedule A attached hereto (the "Marks") pursuant to that certain Amendment No. 13 to Credit Agreement and Amendment 5 to Pledge and Security Agreement, dated as January 22, 2010; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency which is hereby acknowledged, the Administrative Agent hereby releases any security interest it may have in the Marks, without recourse and without representation or warranty of any kind (either express or implied).

Unless otherwise defined herein, terms defined in the Credit Agreement, the Security Agreement, or the TSA and used herein have the meaning given to them in such agreements, as the case may be.
