Assignor covenants and agrees and warrants that it has a full and unencumbered title to the Trademark hereby assigned, and further covenants and agrees that it has the right to grant such rights to said Trademark and that it will, at any time upon request without cost or further compensation, execute and deliver any and all papers or instruments that, in the opinion of the Assignee, may be necessary or desirable to secure said Assignee the full enjoyment of the rights and properties herein conveyed or intended to be conveyed by this instrument.

The Trademark is being assigned, as is the right of protection to the same throughout the world, as well as any continuations, continuations-in-part, renewals, or extensions thereof.

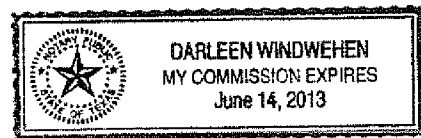
