TRADEMARK SECURITY AGREEMENT

January 20, 2010

United States Patent and Trademark Office

Ladies and Gentlemen:

Please be advised that pursuant to that certain Security Agreement, dated as of January 20, 2010 (as amended, modified, extended or restated from time to time, the "Collateral Agreement"), by and among John Wieland Homes and Neighborhoods, Inc., a Georgia corporation ("Grantor"), John Wieland Homes and Neighborhoods of the Carolinas, Inc., a Georgia corporation, and Bank of America, N.A., as Administrative Agent (the "Administrative Agent") for itself and the other Banks referenced therein (collectively, the "Beneficiaries"), the undersigned Grantor has granted a continuing security interest in and continuing lien upon the trademarks on Schedule 1 to the Administrative Agent for the benefit of the Beneficiaries.

The undersigned Grantor and the Administrative Agent, on behalf of the Beneficiaries, hereby acknowledge and agree that the security interest in the trademarks on Schedule 1 hereto (i) is subject to the terms of the Collateral Agreement, (ii) may only be terminated in accordance with the terms of the Collateral Agreement and (iii) is not to be construed as an assignment of any trademark or trademark application.




