RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of February 1, 2010 ("Effective Date") in favor of Muzak Holdings LLC ("Holdings"), Muzak LLC (the "Borrower") and certain of its Subsidiaries (collectively with Holdings and the Borrower, the "Grantors" by The Bank of New York Mellon, as Administrative Agent and Collateral Agent under the Security Agreement (collectively, the "Agents").

WHEREAS, Grantors and Bear Stearns Corporate Lending Inc. ("BSCL") entered into that certain Guarantee and Collateral Agreement by and between Grantors, BSCL, as collateral agent, and the other parties thereto, dated April 15, 2005 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantors granted to BSCL, as collateral agent for the benefit of the Secured Parties, a lien on and security interest in all of its right, title and interest in, to and under certain trademarks, including those set forth on Schedule A hereto (collectively, the "Trademark Collateral") with the United States Patent and Trademark Office;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 8, 2005, at Reel 3099, Frame 0671;

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement Assignment (Trademarks), dated January 7, 2009, by and between BSCL and Agents, (the "Assignment Agreement"), BSCL assigned its rights, powers, privileges and obligations under the Security Agreement to Agents;

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office on January 7, 2009, at Reel 3914, Frame 0905; and

WHEREAS, Grantors have paid all of their outstanding indebtedness under the Credit Agreement, dated as of April 15, 2005, as amended, by and among the Borrower, Holdings, each of the Lenders from time to time party thereto, and the Agents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agents hereby, without representation, warranty or recourse: (i) terminate, cancel and release any and all security interests it has against the Trademark Collateral, and (ii) re-assigns any right, title and interest it may have in, to and under the Trademark Collateral to Grantors.

The Agents shall, at Grantors' sole cost and expense, and without representation, warranty or recourse, take all further actions, and provide to Grantors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or

other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.


This Release shall be governed by and construed in accordance with the laws of the State of New York.
