**TRADEMARK ASSIGNMENT**

QINC hereby assigns, transfers and sets over to QAG, its heirs, successors, legal representatives and assigns all of its right, title and interest in and to the Mark, together with the business and the good will of the business which is or will be symbolized by the Mark, and all rights and privileges under the Mark, including the right to renew and/or register the Mark anywhere in the world, and all rights to recover for damages and profits for infringement in the United States and throughout the world.

QINC acknowledges and agrees that it shall execute all other such documents, and take all such further actions, as QAG may reasonably request in order to effectuate the terms and purposes of this agreement.

QINC hereby assigns to QAG, and QAG assumes, all rights, privileges, duties and obligations under any and all license agreements with third parties respecting use of the Mark.
