TRANSLATION

Declaration of Luis Francisco Perdomo Hernandez under TMEP § 503.06(c)

1. I am the President of Havana Rum & Liquors, S.A. ("HRL"), which has a place of business at 44 St., No. 305, Between 3rd and 5th Avenues, Miramar, Havana, Cuba. I have authority to speak for that entity on the topics covered in this Declaration. All statements made herein of my own knowledge are true. Statements made in this declaration concerning legal proceedings in the United States are upon information provided by United States counsel and are believed to be true.

2. HRL is the owner of U.S. Trademark Reg. No. 1,956,024 for the mark RON CANEY ORO LIGHT LEGITIMO RON CUBANO (design) and U.S. Trademark Reg. No. 2,436,862 for the mark CUBAY (collectively, the "HRL Marks"). HRL filed the application for the HRL Marks on December 20, 1994, and February 10, 2000, respectively, and at no time thereafter has HRL assigned its rights to the HRL Marks to any party.

3. On December 8, 2009, an "Assignment Cover Sheet" with an accompanying document was filed, purporting to transfer the HRL Marks to Mr. Nilo Jerez of Coral Gables, Florida ("Jerez"). This recorded document was submitted with erroneous information, as detailed below.

4. The accompanying document was an *ex parte* Writ of Attachment on Judgment ("Writ") that Jerez obtained from the Clerk of the United States District Court for the District of Columbia without Court order, in violation of United States law.

5. Jerez then purported to execute the Writ of Attachment against the HRL Marks by recording the Writ under Reel/Frame Number 4110/0204.

6. By recording the Writ, Jerez sought to seek satisfaction of a default judgment issued by a Florida state court (the Eleventh Judicial Circuit In and For Miami-Dade County, Florida) against the Republic of Cuba on January 30, 2007, Case No. 05-18719 CA9 ("State Default Judgment"). On May 6, 2009, the United States District Court for the Southern District of Florida, in Case No. 08-23405, issued a judgment upon default giving "full faith and credit" to the State Default Judgment ("Federal Florida Default Judgment"). Jerez registered the "full faith and credit" default judgment in the United States District Court for the District of Columbia on September 1, 2009 pursuant to 28 U.S.C. § 1963 ("Registered Judgment"), with docket number 09-00466. On October 2, 2009, Jerez obtained from the Clerk of this Court the Writ in satisfaction of the Registered Judgment.

7. HRL was not named in the State Default Judgment, the Federal Florida Default Judgment, or the Registered Judgment (hereafter sometimes collectively "Judgments") HRL was not a party to the lawsuits and proceedings resulting in said Judgments, did not participate with any those lawsuits or proceedings, and was not given any notice of those lawsuits and proceedings.

8. No court has ever authorized execution upon HRL's property, including the HRL Marks, to satisfy the Judgments. No court has ever determined or held HRL liable for the Judgments.

9. On November 19, 2009, HRL filed a motion in the United States District Court for the District of Columbia, Case No. 09-mc-00466, to vacate the Writ as invalid and contrary to law. On December 21, 2009, Jerez filed papers in opposition to that motion to vacate. HRL's reply papers were filed on January 26, 2010. The Court has not yet decided HRL's motion to vacate the Writ.

10. Jerez' purported execution by recording the Writ under an Assignment Cover Sheet, purporting to show an assignment of the HRL Marks to Jerez, was improper, unlawful, and of no effect for multiple reasons, including without limitation:

(a) HRL was not named in the State Default Judgment, the Federal Florida Default Judgment or the Registered Judgment, was not a party to the lawsuits and proceedings resulting in said Judgments, did not participate in any of those lawsuits or proceedings, and was not given any notice of those lawsuits and proceedings.

(b) The United States Department of Treasury's Cuban Assets Control Regulations ("CACR"), 31 C.F.R. §§ 515.201, 515.203, 515.310, prohibit execution upon property, including specifically trademark registrations, in which Cuba or a Cuban national has an interest, unless execution is specifically licensed by the Treasury Department's Office of Foreign Assets Control ("OFAC"). HRL is a Cuban national, and therefore this prohibition applies to its trademarks. OFAC has not issued a license authorizing the Writ, execution on the HRL Marks or any other HRL property, or execution in satisfaction of Jerez's Judgments. Under the CACR, the Writ, and any purported execution thereon, including the Assignment Cover Sheet, are therefore "null and void, and shall not be the basis for the assertion or recognition of any interest in or right, remedy, power or privilege with respect to" the HRL Marks or HRL's other property. 31 C.F.R. § 515.203.

(c) In the Writ, Jerez asserts that HRL is an "agency or instrumentality" of the Republic of Cuba, and Jerez, by the Writ, seeks to satisfy a judgment against the Republic of Cuba. First, under U.S. law HRL is not an "agency or instrumentality" of the Republic of Cuba, as it is owned by Cuban juridical entities different than the Republic of Cuba. No judge of a court has ordered the Writ or execution upon the property of HRL or any other property in satisfaction of the Judgments. Rather, the Clerk of the Court issued the writ, contrary to the FSIA, without judicial order. Therefore, both the writ and the Assignment Cover Sheet have no effect or validity.

Under Cuban law, HRL is not responsible for the debts or obligations of its shareholders. Furthermore, HRL is not responsible for the debts and obligations of third parties, including without limitation the Republic of Cuba. HRL's assets and liabilities are its own, and not the assets or liabilities of its shareholders. Likewise, the assets and liabilities of HRL are not the assets or liabilities of third parties, including the Republic of Cuba. HRL is owned by Cuba Ron S.A. and the Empresa de Bebidas y Refrescos Villa Clara. Each of the shareholders is a company with legal personality, its own assets and management, organized under the laws of Cuba. The Board of Shareholders is the highest governing authority of the company. The Board of Shareholders designates the Board of Directors and the administrative bodies of the company. The administration and representation of HRL is carried out by the Board of Directors, subject to the authority and direction of the Board of Shareholders. The Board of Shareholders, *inter alia*, designates the members of the Board of Directors, determines the number of persons who shall serve on this Board, amends the Statutes, and decides upon the distribution of dividends. It is the responsibility of the Board of Directors to manage the enterprise in all of its aspects, subject to the Board of Shareholders' authority and direction.

(d) As applied to the HRL Marks, the Writ and the Assignment Cover Sheet are contrary to the United States' obligations under the General Inter-American Convention for Trade Mark and Commercial Protection (the "IAC"), 46 Stat. 2907 (1930) and the Agreement on Trade-Related Aspects of Intellectual Property Rights ("TRIPS"), 33 I.L.M. 81 (1994).

11. HRL remains the true and correct owner of the HRL Marks. The chain of title for the HRL Marks should not be considered altered by the incorrect "Assignment" recorded. HRL has been and continues to be the owner of the HRL Marks.

12. United States counsel for HRL in this matter has contacted counsel for Jerez, William John McKeague, and asked him to file corrective documents. Mr. McKeague refused.

I declare under penalty of perjury under the laws of the United States that the foregoing is true and correct.

Declaración de Luis Francisco Perdomo Hernández según TMEP § 503.06(c)

1. Soy Presidente de Havana Rum & Liquors, S.A. ("HRL"), cuyo domicilio comercial es Calle 44, Nº 305, entre las Avenidas 3ª y 5ª, Miramar, La Habana, Cuba. Poseo la facultad de representar a dicha persona jurídica en los temas que se cubren en esta declaración. A mi entender, todas las declaraciones que contiene el presente documento son verídicas. Las afirmaciones presentes en esta declaración que guardan relación con procesos legales en los Estados Unidos se basan en información suministrada por nuestros abogados de Estados Unidos y se consideran verídicas.

2. HRL es el propietario del Reg. de Marca Nº 1.956.024 de los Estados Unidos para la marca RON CANEY ORO LIGHT LEGITIMO RON CUBANO (diseño) y el Reg. de Marca Nº 2.436.862 de los Estados Unidos para la marca CUBAY (denominadas colectivamente, las "Marcas HRL"). HRL presentó las solicitudes para las Marcas HRL el 20 de diciembre de 1994 y el 10 de febrero de 2000, respectivamente y, de allí en adelante, en ningún momento ha cedido HRL a parte alguna sus derechos a las Marcas HRL.

3. El 8 de diciembre de 2009, se presentó una "Assignment Cover Sheet" con un documento adjunto, la que pretendía transferir las Marcas HRL al Sr. Nilo Jerez de Coral Gables, Florida ("Jerez"). Este documento público se presentó con información errónea, como se detalla a continuación.

4. El documento adjunto era un Mandamiento de ejecución judicial *ex parte* ("Mandamiento") que Jerez obtuvo del Secretario del Tribunal de Distrito de los Estados Unidos para el Distrito de Columbia sin una orden judicial, lo que infringe las leyes de Estados Unidos.

5. Jerez entonces pretendía ejecutar el Mandamiento de ejecución judicial contra las Marcas HRL mediante el registro del Mandamiento, según el Rollo / Imagen Número 4110/0204.

6. Al hacer público el Mandamiento, Jerez pretendía conseguir el cumplimiento de un fallo por rebeldía emitido por un tribunal estatal de Florida (Undécimo Circuito Judicial En y Para el Condado de Miami-Dade, Florida) contra la República de Cuba, el 30 de enero de 2007, caso Nº 05-18719 CA9 ("Fallo Estatal por Rebeldía"). El 6 de mayo de 2009, el Tribunal de Distrito de los Estados Unidos para el Distrito Sur de Florida, en el caso Nº 08-23405, emitió un fallo por rebeldía dando "Plena fe y crédito" al Fallo Estatal por Rebeldía ("Fallo Federal por Rebeldía de Florida"). Jerez inscribió el fallo por rebeldía de "Plena fe y crédito" en el Tribunal de Distrito de los Estados Unidos para el Distrito de Columbia el 1 de septiembre de 2009, conforme a 28 U.S.C. § 1963 ("Fallo Registrado"), número de expediente 09-00466. El 2 de octubre de 2009, Jerez obtuvo de parte del Secretario de este Tribunal el Mandamiento para conseguir el cumplimiento del Fallo Registrado.

7. HRL no fue nombrada el Fallo Estatal por Rebeldía, ni en el Fallo Federal por Rebeldía de Florida ni en el Fallo Registrado (en lo sucesivo algunas veces denominadas colectivamente "los Fallos"); HRL no fue parte en las demandas ni procesos que originaron dichos Fallos, ni participó en ninguna de dichas demandas o procesos, ni tampoco recibió aviso de las demandas o procesos.

8. Ningún tribunal ha autorizado la ejecución de la propiedad de HRL, incluidas las Marcas HRL, para cumplir con los Fallos. Ningún tribunal ha determinado ni sostenido que HRL sea responsable de cumplir con los Fallos.

9. El 19 de noviembre de 2009, HRL presentó un recurso ante el Tribunal de Distrito de los Estados Unidos para el Distrito de Columbia, Caso Nº 09-mc-00466, para la anulación del Mandamiento por considerarlo inválido y contrario a la ley. El 21 de diciembre de 2009, Jerez presentó documentación en contra del recurso de anulación. Los documentos de respuesta de HRL se presentaron el 26 de enero de 2010. El tribunal aún no ha decidido sobre el recurso de HRL para anular el Mandamiento.

10. La presunta ejecución de Jerez, mediante el registro del Mandamiento según la Assignment Cover Sheet, con la intención de demostrar una cesión de las Marcas HRL a Jerez, fue indebida, ilegal y no tiene efecto por varias razones, entre otras, sin limitación:

(a) HRL no fue nombrada en el Fallo Estatal por Rebeldía, ni en el Fallo Federal por Rebeldía de Florida ni en el Fallo Registrado, no fue parte en las demandas ni procesos que originaron dichos Fallos, ni participó en ninguna de dichas demandas o procesos ni tampoco recibió aviso de las demandas o procesos.

(b) Las Cuban Assets Control Regulations ("CACR") del Departamento del Tesoro de los Estados Unidos, 31 C.F.R. §§ 515.201, 515.203, 515.310, prohíben la ejecución de una propiedad, incluido específicamente un registro de marcas, en la cual Cuba o un ciudadano cubano o persona jurídica cubana posea un interés, a menos que la ejecución sea autorizada por la Oficina de Control de Activos Extranjeros (OFAC, por sus siglas en inglés) del Departamento del Tesoro. HRL es una persona jurídica cubana y, por lo tanto, esta prohibición se aplica a sus marcas. OFAC no ha emitido una licencia para autorizar el Mandamiento, ejecutar las Marcas HR, ni ninguna otra propiedad de HRL, ni tampoco para la ejecución en cumplimiento de los Fallos de Jerez. Según CACR, el Mandamiento, y cualquier pretensión de ejecución del mismo, entre éstos la Assignment Cover Sheet, por lo tanto, son "nulos y no tienen efecto, y no se considerarán fundamento para ningún reclamo o reconocimiento de cualquier interés en, o derecho, facultad, recurso o privilegio con respecto a" las Marcas HRL u otra propiedad de HRL. 31 C.F.R. § 515.203.

(c) En el Mandamiento, Jerez afirma que HRL es una "agencia o dependencia" de la República de Cuba, y Jerez, mediante dicho Mandamiento, pretende conseguir el cumplimiento de un fallo en contra de la República de Cuba. Primero, bajo la ley de los EEUU HRL no es una "agencia o dependencia" de la República de Cuba porque es propiedad de entidades jurídicas cubanas distintas a la República de Cuba. Ningún juez de un tribunal ha ordenado el Mandamiento ni la ejecución sobre la propiedad de HRL o ninguna otra propiedad en cumplimiento de los Fallos. Aun así, el Secretario del Tribunal emitió un Mandamiento, contrario a la FSIA, sin una orden del tribunal. Por lo tanto, el Mandamiento y la Assignment Cover Sheet no tienen efecto ni validez.

Bajo las leyes cubanas, HRL no es responsable por las deudas u obligaciones de sus accionistas. Además, HRL no es responsable por las deudas u obligaciones de terceras partes, incluyendo sin limitación la República de Cuba. Los activos y pasivos de HRL son los propios y no los activos o pasivos de sus accionistas. Asimismo los activos y pasivos de HRL no son activos y pasivos de terceras partes, incluyendo la República de Cuba. Los accionistas de HRL son Cuba Ron S.A. y la Empresa de Bebidas y Refrescos Villa Clara. Cada uno de los accionistas es una compañía con personalidad legal, activos y gerencia propia, organizada bajo las leyes de Cuba. La Junta de Accionistas es la máxima autoridad de gobierno de la compañía. La Junta de Accionistas designa a la Directiva y a los cuadros administrativos de la compañía. La administración y la representación de HRL es llevada a cabo por la Junta de Directores, sujeto a la autoridad y dirección de la Junta de Accionistas. La Junta de Accionistas, *inter alia*, designa a los miembros de la Junta de Directores, determina la cantidad de personas que van a formar

parte del mismo, enmienda los Estatutos y decide la distribución de los dividendos. Es responsabilidad de la Junta de Directores manejar la empresa en todos sus aspectos, sujeto a la autoridad y dirección de la Junta de Accionistas.

(d) Según se aplica a las Marcas HRL, el Mandamiento y la Assignment Cover Sheet son contrarios a las obligaciones de los Estados Unidos según la Convención General Interamericana de Protección Marcaria y Comercial ("IAC", por sus siglas en inglés), 46 Stat. 2907 (1930) y el Acuerdo sobre los aspectos de los derechos de propiedad intelectual relacionados con el comercio ("TRIPS", por sus siglas en inglés), 33 I.L.M. 81 (1994).

11. HRL sigue siendo el propietario verídico y correcto de las Marcas HRL. La cadena de título de las Marcas HRL no se debe considerar alterada por la "Cesión" incorrecta que fue publicada. HRL fue y continúa siendo el propietario de las Marcas HRL.

12. Los abogados de los Estados Unidos de HRL en este asunto se han comunicado con el abogado de Jerez, William John McKeague y le solicitaron presentar documentos correctivos. El Sr. McKeague se rehusó.

Declaro, so pena de perjurio según las leyes de los Estados Unidos, que todo lo anterior es verídico y correcto.
