TRADE-MARK ASSIGNMENT AGREEMENT

This Trade-mark Assignment Agreement is made effective the last date of execution listed below by and between:

Difco Performance Fabrics Inc., whose principal office or place of business is 1411 Peel Street, Suite 1411, Montreal, Quebec, H3A 1S5, Canada ("Assignor")

and

Fabrene, Inc., whose principal office or place of business is 240 Dupont Road, P.O. Box 4040, North Bay, Ontario, P1B 9B4, Canada ("Assignee")

WHEREAS Assignor is the owner in Canada of the trade-mark **3-D** and corresponding Canadian trade-mark registration number TMA432,023 registered before the Canadian Intellectual Property Office in association with the goods "Textile fabrics" which issued to registration on August 19, 1994 (the "**Canadian Mark and Registration**")

AND WHEREAS Assignor is the owner in the United States of the trade-mark **3-D** and corresponding United States trade-mark application number 77/805,752 filed before the United States Patent and Trademark Office in association with the goods "Textile fabrics" on August 17, 2009 (the "**U.S. Mark and Application**");

AND WHEREAS Assignor desires to convey, transfer, assign, deliver and contribute to Assignee all of its right, title and interest in and to the Canadian Mark and Registration as well as the U.S. Mark and Application (collectively referred to as the "**3-D Mark**");

AND WHEREAS Assignee desires to accept the conveyance, transfer, assignment, delivery and contribution of all of Assignor's right, title and interest in and to the 3-D Mark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby conveys, transfers, assigns, delivers, and contributes to Assignee all of Assignor's right, title, and interest of whatever kind in and to the 3-D Mark and all goodwill associated with the 3-D Mark, together with all income, royalties, and damages hereafter due or payable to Assignor with respect to the 3-D Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the 3-D Mark as well as all rights to sue and recover for past, present and future infringements or misappropriations of the 3-D Mark.

2. Assignor hereby covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting full right, title, and interest in the 3-D Mark to Assignee.

3. Assignor hereby undertakes to never again adopt, use, apply for or register the trade-mark 3-D or any other trademark that is confusingly similar to the trade-mark 3-D in Canada and the United States without first obtaining authorization and a proper licence from Assignee.
