DECLARATION OF DAIVA K. TAUTVYDAS
ATTORNEY TO POW, INC.

1. I am an attorney licensed to practice law in the State of Washington. I work for the law firm of Christensen O'Connor Johnson Kindness PLLC ("COJK"), having a principal place of business at 1420 5th Avenue, Suite 2800, Seattle, Washington 98101.

2. COJK represents Pow, Inc., a corporation of the State of Washington, having a principal place of business at 4509 Interlake Avenue North, #287, Seattle, Washington 98103.

3. Pow, Inc. acquired U.S. Trademark Registration No. 2819749, and the mark POW, from Dustin E. Goss by way of an agreement entitled Contribution Agreement, dated June 30, 2006. The transfer in that agreement was confirmed in a Nunc Pro Tunc Assignment, effective June 30, 2006, and recorded at the U.S. Patent and Trademark Office on March 1, 2010, at Reel/Frame 4158/0501.

4. Dustin E. Goss acquired U.S. Trademark Registration No. 2819749, and the mark POW, from Goss Enterprises, Inc. A Nunc Pro Tunc Assignment memorializing that acquisition, effective June 29, 2003, was recorded at the U.S. Patent and Trademark Office on March 1, 2010, and Reel/Frame 4158/0493.

5. U.S. Trademark Registration No. 2819749, for the mark POW, was originally owned by Goss Enterprises, Inc.


6. Goss Enterprises, Inc. was formed on June 8, 2000, and dissolved on September 22, 2003.

7. An assignment Nunc Pro Tunc transferring U.S. Trademark Registration No. 2819749, for the mark POW, from Goss Enterprises, Inc. directly to Pow, Inc, having an effective date of June 30, 2006, was recorded at the U.S. Patent and Trademark Office on March 1, 2010, at Reel 4158/Frame 0172.

8. Goss Enterprises, Inc. was dissolved in 2003. Accordingly, Goss Enterprises, Inc. did not exist on June 30, 2006, the effective date of the assignment referenced in paragraph 7 of this

Declaration, therefore the assignment is void and ineffective, and should not be part of the chain of title for U.S. Registration No. 2819749, for the mark POW.

9. As of the date of this Declaration, Pow, Inc, is the owner of U.S. Trademark Registration No. 2819749, and the mark POW.
