TRADEMARK ASSIGNMENT**

THIS ASSIGNMENT (the "Assignment") is made and entered into effective as of March 26, 2010, ("Effective Date"), by and between Zero-Rust, Inc. ("Assignor") an Illinois corporation, and Amteco, Inc. ("Assignee"), a Missouri corporation.

This assignment supplements and implements the Trademark Purchase Agreement dated March 26, 2010 as it regards the assignment of the entire right, title, and interest in and to U.S. Trademark Registration No. 1,545,071 for ZERO-RUST (hereinafter the "Mark").

2. Assignor further agrees to execute and deliver such other or further documents or instruments as may be necessary to perfect Assignee's rights in and to the Mark.
3. This Assignment provided hereby includes the right to recover all damages for infringement of the Mark, whether such infringement occurred in the past or occurs in the future, as fully as if Assignor had filed such action in its own name. Further, Assignor agrees to cooperate in any such actions to the extent reasonably required by Assignee to enforce the rights transferred hereunder.
