NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the ASSIGNOR by these presents does assign and transfer unto the ASSIGNEE, its successors and assigns, all right, title and interest in and to the Assets;

AND, ASSIGNOR covenants and agrees that at any time it will execute and deliver any papers, make all rightful oaths, testify in any legal proceedings and perform all other lawful acts reasonably deemed necessary or desirable by the ASSIGNEE, its successors, legal representatives or assigns, to convey or perfect title to the Assets and the ASSIGNOR shall pay any and all expenses incurred in conveying or perfecting title to such Assets;

AND, ASSIGNOR hereby requests the appropriate officials at the various patent and trademark offices throughout the world to issue certificates of registration, certificates of recordation and letters patent to the ASSIGNEE.
