## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made as of April 8, 2010 ("Effective Date") by and between Ozburn-Hessey Logistics, LLC ("Grantor") and Morgan Stanley Senior Funding, Inc., as administrative agent (the "Administrative Agent"). Capitalized terms not defined herein have the meaning given to them in the Pledge and Security Agreement (defined below).

**WHEREAS**, Grantor and the Administrative Agent entered into that certain Pledge and Security Agreement by and between Grantor, the Administrative Agent and the other parties thereto dated August 10, 2005 (the "Pledge and Security Agreement");

**WHEREAS**, pursuant to the Pledge and Security Agreement, Grantor granted to the Administrative Agent a lien on and security interest in all of its right, title and interest in, to and under certain intellectual property and entered into that certain Trademark Security Agreement dated August 10, 2005 (the "Trademark Security Agreement") for the purpose of recording such security interest with respect to the trademarks of Grantor, including those items set forth on Schedule A hereto (as further defined in the Trademark Security Agreement, the "Trademark Collateral") with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 15, 2005, at Reel 003140, Frames 0825; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to the Administrative Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademark Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademark Collateral to Grantor.

The Administrative Agent shall, upon Grantor's written request and at the Grantor's sole cost and expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release, unless any of the foregoing actions would be contrary to applicable law or the Loan Documents, but in each case without recourse to the Administrative Agent, the Lenders or any other Secured Party, and without any representation or warranty of any kind, express or implied.


This Release shall be governed by and construed in accordance with the laws of the State of New York.

The Administrative Agent hereby authorizes and requests that the Commissioner of Trademarks and any other applicable United States government officer record this Release.
