**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS
(ULT SERVICE MARK)**

Reference is made to (i) the Grant of Security Interest in Trademark Rights dated as of July 31, 2007 (the "Trademark Security Agreement") made by ENGLE HOMES DELAWARE, INC., a Delaware corporation (the "Company"), in favor of CITICORP NORTH AMERICA, INC., as administrative agent (the "Administrative Agent") for its benefit and the ratable benefit of the Lenders pursuant to the Second Lien Term Loan Credit Agreement, dated as of July 31, 2007 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), entered into by and among TOUSA, INC., certain of its subsidiaries signatories thereto, the Administrative Agent, Citigroup Global Markets Inc. and certain lenders party thereto and (ii) the Successor Agent and Amendment Agreement dated as of January 28, 2008 (the "Successor Agreement") among TOUSA, Inc., each Subsidiary Borrower, WELLS FARGO BANK, N.A., as successor administrative agent (the "Successor Administrative Agent"), the Administrative Agent and each of the Requisite Lenders signatory thereto pursuant to which the Administrative Agent succeeded to the administrative agent position. Capitalized terms used herein and not otherwise defined have the meanings given to such terms in the Credit Agreement.

The Company and the Administrative Agent are parties to that Security Agreement dated as of July 31, 2007 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which the Company pledged and granted a continuing security interest in (i) the service mark "UNIVERSAL LAND TITLE & Design," registered with the U.S. Patent and Trademark Office with registration number 2991710; and (ii) the service mark "UNIVERSAL LAND TITLE, INC.," registered with the U.S. Patent and Trademark Office with registration number 2838446 (collectively, the "ULT Service Marks") to the Administrative Agent for its benefit and the ratable benefit of the Lenders pursuant to the Security Agreement. Pursuant to the Successor Agreement, the Successor Administrative Agent succeeded to such security interest. This security interest has been further evidenced by the Trademark Security Agreement recorded with the U.S. Patent and Trademark Office on August 13, 2007 at Reel/Frame number 003600/0073.

The Successor Administrative Agent, on its own behalf and on behalf of the Lenders, hereby releases and relinquishes its security interest in the ULT Service Marks. The Successor Administrative Agent agrees that it will, upon request and at the Company's expense, execute any document, certificate or agreement, and take any other action, that the Company reasonably requests and are necessary to evidence the release of the security interest in the ULT Service Marks.

This release is executed by the Successor Administrative Agent without representation or warranty of any kind.

IN WITNESS WHEREOF, the Successor Administrative Agent has executed and delivered this Release of Security Interest in Trademark Rights (ULT Service Marks) as of December 10, 2009.
