**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS
(ULT SERVICE MARKS)**

Reference is made to the Grant of Security Interest in Trademark Rights dated as of July 31, 2007 (the "**Trademark Security Agreement**") made by ENGLE HOMES DELAWARE, INC., a Delaware Corporation (the "**Company**"), in favor of CITICORP NORTH AMERICA, INC., as Administrative Agent (the "**Administrative Agent**") for its benefit and the ratable benefit of the Lenders and Issuers pursuant to the Second Amended and Restated Credit Agreement dated as of July 31, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), entered into by and among TOUSA, INC., and certain of its subsidiaries signatories thereto.

The Company and the Administrative Agent are parties to that Amended and Restated Security Agreement dated as of July 31, 2007 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**"), pursuant to which the Company pledged and granted a continuing security interest in (i) the service mark "UNIVERSAL LAND TITLE & Design," registered with the U.S. Patent and Trademark Office with registration number 2991710; and (ii) the service mark "UNIVERSAL LAND TITLE, INC.," registered with the U.S. Patent and Trademark Office with registration number 2838446 (collectively, the "**ULT Service Marks**") to the Administrative Agent for its benefit and the ratable benefit of the Lenders and Issuers pursuant to the Security Agreement. This security interest has been further evidenced by the Trademark Security Agreement recorded with the U.S. Patent and Trademark Office on August 13, 2007 at Reel/Frame number 003600/0092.

The Administrative Agent, on its own behalf and on behalf of the Lenders and Issuers, hereby releases and relinquishes its security interest in the ULT Service Marks. The Administrative Agent agrees that it will, upon request and at the Company's expense, execute and deliver to the Company a UCC-3 termination statement with respect to the ULT Service Marks, and any further release as may be required to be filed with the U.S. Patent and Trademark Office as shall be reasonably necessary to give effect to this Release of Security Interest in Trademark Rights (ULT Service Marks).

This release is executed by the Administrative Agent without representation or warranty of any kind.

IN WITNESS WHEREOF, the Administrative Agent has executed and delivered this Release of Security Interest in Trademark Rights (ULT Service Marks) as of December 10, 2009.
