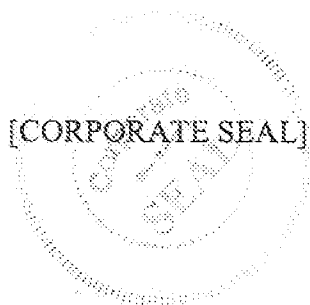



ARTICLES OF INCORPORATION

The undersigned certify that:


1. They are the Senior Vice President and the Secretary, respectively of Improvement Direct, Inc., a California corporation (the "Corporation).
2. Article ONE of the Corporation's Articles of Incorporation is amended in its entirety to read as follows:


"ONE: That the name of the corporation is Build.com, Inc."

3. The foregoing amendment of Articles of Incorporation has been duly approved by the Corporation's Board of Directors.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 10,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
