Assignment Of Trademarks

WHEREAS, Assignor granted to **FIFTH THIRD BANK** (the "**Lender**"), a continuing priority security interest in and general lien upon Assignee's general intangibles and other assets, including but not limited to the Trademarks; and

WHEREAS, pursuant to a certain Loan Purchase and Security Agreement dated as of the date hereof by and between the Lender and **MZB INTERNATIONAL LLC**, a New York limited liability company ("the "**Assignee**") the Assignee has purchased and assumed certain loans of Assignor to Lender; and

WHEREAS, pursuant to a certain Peaceful Possession Letter dated as of the date hereof by and between Assignor, Barry Rosenbaum, Barry Rosenbaum, as Trustee of the Barry Rosenbaum Revocable Trust u/t/a/d March 14, 2000 and the Assignee (the "**Peaceful Possession Letter**") and a certain Agreement dated as of the date hereof by and among Assignor, Barry Rosenbaum, Barry Rosenbaum, as Trustee of the Barry Rosenbaum Revocable Trust u/t/a/d March 14, 2000 and the Assignee (the "**Agreement**"), Assignor has agreed to sell, convey, transfer, and assign to Assignee all of Assignor's Trademarks, and the goodwill associated therewith, among other collateral surrendered by Assignor to Assignee under the Peaceful Possession Letter and Agreement; and

WHEREAS, Assignor now makes the Assignment to convey, transfer and assign to Assignee the Trademark, together with the business symbolized by and appurtenant thereto and the goodwill associated therewith;

NOW, THEREFORE, for the sum of Ten (\$10.00) Dollars and other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged,

ASSIGNOR does hereby sell, assign and transfer to the **ASSIGNEE** all right, title and interest in and to the Trademarks, together with all goodwill and business symbolized by said Trademarks and appurtenant thereto, and all causes of action and claims for damages therefor, as well as the right to sue for past and present infringement thereof, free and clear of all liens and encumbrances. Upon execution and delivery of this Assignment, all liens encumbrances, mortgages, security interests, pledges, claims, equities, interests and other interests or charges of any kind or nature whatsoever that the Lender or any other party may have in or to the Trademarks shall be and shall be deemed discharged.

TO HAVE AND TO HOLD the same unto said Assignee, its successors and assigns forever.

1. Assignor represents and warrants to Assignee that (a) Assignor is the owner of the entire right, title and interest in and to the Trademarks, including but not limited to common law and statutory rights thereto and the goodwill and business symbolized by the Trademarks, and (b) the Trademarks have been continuously used by Assignor (and its affiliates and/or licensees) in interstate commerce from the said date of first use until the date hereof.

2. Assignor hereby agrees, at any time and from time to time (at Assignee's expense), to execute all instruments, documents and papers and to perform such other proper acts as Assignee, its successors or assigns may reasonably request, to preserve, perfect, evidence or validate this Assignment, to secure to Assignee, its successors or assigns the rights hereby assigned.

3. Assignor hereby agrees, at any time and from time to time, to cooperate in good faith in any action to the extent reasonably required by Assignee, without cost to Assignor, to enforce the rights transferred hereunder.

4. This Assignment may not be waived, changed or terminated or modified without the written and signed consent of Assignor and Assignee.

5. This Assignment shall be binding upon and inure to the benefit of the parties hereto, their successors and assigns. This Assignment may be executed in multiple counterparts, each of which when executed shall constitute one and the same agreement.






