ASSIGNMENT OF INTELLECTUAL PROPERTY

Whereas, James W. Rane (hereinafter referred to as "Rane") is the owner of the common law and statutory rights to the trademark "HUGGIN' MOLLY'S" including the federal registrations thereof (registration numbers 3,149,160 and 3,151,447) (hereinafter collectively referred to as "the Trademarks");

Whereas, Huggin' Molly's, Inc. an Alabama corporation (hereinafter referred to as "Huggin'"), is desirous of acquiring the entire interest of Rane in and to the Trademarks;


Now, therefore, for ten dollars (\$10) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Rane does hereby sell, assign, convey and transfer to Huggin' all of Rane's right, title and interest in and to the HUGGIN' MOLLY'S trademark (including federal registration numbers 3,149,160 and 3,151,447), together with the goodwill of the business symbolized by the Trademark and common law rights thereto, the same to be held and enjoyed by Huggin', for its own use and benefit and that of its successors, assigns and legal representatives, together with all claims for damages by reason of past infringement, with the right to sue for and collect the same for its own use and for the use of its successors, assigns or other legal representatives.

Rane represents and warrants to Huggin' that he has full right, power and authority to make this assignment to Huggin' in the manner set forth above, and that Rane is transferring to Huggin' good and marketable title to the Trademarks, free and clear of all liens, security interests, claims, interests, options, encumbrances, or indebtedness of any kind.

Rane does hereby covenant and agree to execute and deliver such other and further instruments and take such other and further actions as may be necessary or appropriate to transfer to Huggin' any and all interest in and to the Trademarks.
