**IP SUPPLEMENT**

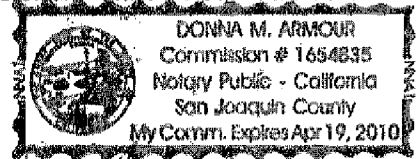
