RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of May 10, 2010 by JPMORGAN CHASE BANK, N.A., (successor by merger to Bank One, NA) (the "Lender"), with its office at 10 South Dearborn, Chicago, Illinois 60603 to UNIGROUP, INC., a Missouri corporation (the "Grantor"), with its chief executive office and principal place of business at One Premier Drive, Fenton, Missouri 63026, as follows:

WHEREAS, on November 23, 1999, the Grantor, certain other entities party thereto and Bank of America, N.A. entered into a Security Agreement (as amended, the "Original Security Agreement");

WHEREAS, pursuant to the Original Security Agreement, the Grantor granted to Bank of America, N.A., among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, the Original Security Agreement was recorded in the United States Patent & Trademark Office ("USPTO") on December 6, 1999 at reel/frame 2001/741;

WHEREAS, on June 23, 2000, Bank of America, N.A. assigned all of its right, title and interest as collateral agent in the Original Security Agreement to Bank One, NA;

WHEREAS, said assignment was recorded with the USPTO on March 13, 2003 at reel/frame 2690/0001;

WHEREAS, on November 25, 2003, Grantor, certain other entities party thereto and Bank One, NA amended and restated the Original Security Agreement pursuant to that certain Amended and Restated Security Agreement (as further amended, restated, supplemented or otherwise modified from time to time, the "Amended and Restated Security Agreement", and collectively with the Original Security Agreement, the "Security Agreement");

WHEREAS, the Amended and Restated Security Agreement was recorded with the USPTO on July 13, 2004 at reel/frame 2890/602; and

WHEREAS, the Lender wishes to release its security interest in the Trademarks.

NOW THEREFORE, as the Grantor has satisfied its obligations under the Security Agreement, the Lender hereby releases, at the Grantor's sole cost and expense, all right, title and interest in and to the Trademarks, including its security interest in and lien upon the Trademarks.
