INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Assignment"), dated as of May 21, 2010 (the "Effective Date"), is made and entered into by and between International Architectural Group LLC, a Delaware limited liability company ("Assignor"), and International Management Services Group, Inc., a Delaware corporation ("Assignee").

RECITALS

WHEREAS, Assignor and Assignee are parties to that certain Assignment and Assumption Agreement (the "Agreement"), dated as of the date hereof, pursuant to which, among other things, Assignor has agreed to assign and transfer to Assignee certain assets, including, without limitation, the Patents (as defined below) and the Marks (as defined below); and

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to receive, all of Assignor's right, title and interest in and to the Patents and the Marks.

NOW, THEREFORE, in consideration of the mutual promises contained herein and in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound hereby, agree as follows:

1. Definitions.

(a) "Patents" means the issued patents and pending patent applications identified in Attachment A hereto.

(b) "Marks" means the trademarks identified in Attachment B hereto, including, without limitation, all registrations and applications therefor.

2. **Assignment.** Assignor hereby assigns, transfers, sells and conveys to Assignee all of its right, title and interest throughout the world in and to:

(a) the Patents, as well as any reexaminations, extensions, substitutions and reissues thereof and any provisionals, divisionals, continuations, continuations-in-part and any other applications that claim priority from any of the Patents or any patents issuing on any of the Patents, including, without limitation, any foreign patent applications or issued patents, or certificates of invention corresponding thereto, and all rights, claims and privileges pertaining to any of the Patents, including, without limitation, rights to the underlying inventions, the right to prosecute and maintain any of the Patents, and the right to sue and recover damages for past, present and future infringement or other violation or impairment of any of the Patents; and

(b) the Marks, as well as any renewals and extensions thereof, together with the goodwill of the business connected with the use of and symbolized by any of the Marks and all rights, claims and privileges pertaining to any of the Marks and the related goodwill, including, without limitation, the right to sue and recover damages for past, present and future

infringement, dilution or other violation or impairment of any of the Marks and the related goodwill and the right to prosecute and maintain trademark and service mark registrations and applications for any of the Marks.

3. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns.

4. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of New York applicable to contracts made and performed in such State without giving effect to the principles of conflicts of law thereof.

5. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original of this Assignment and all of which, when taken together, shall be deemed to constitute one and the same agreement.
