TRADEMARK COLLATERAL SECURITY AGREEMENT

THIS TRADEMARK COLLATERAL SECURITY AGREEMENT (this "Agreement"), is made as of May ~~20~~²⁷, 2010, by Poly-D LLC, a Rhode Island limited liability company ("Borrower"), in favor of Sealed Air Corporation (US), a Delaware Corporation (the "Secured Party").

WHEREAS, Borrower has adopted, used and is using, and is the sole owner of the marks set forth on Schedule I hereof (the "Marks");

WHEREAS, pursuant to that certain Security Agreement (the "Security Agreement"), dated of even date herewith, by and between Borrower and the Secured Party, as collateral security for the prompt payment and performance in full when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations (as defined in the Security Agreement), Borrower pledged and granted to the Secured Party, a security interest in all of Borrower's right, title and interest in certain collateral, including the Marks, together with the goodwill of the business symbolized by the Marks; and

WHEREAS, it is the purpose of this document to memorialize the aforementioned security interest in a form suitable for recordation in the United States Patent and Trademark Office;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of even date herewith, Borrower does hereby collaterally assign and grant to the Secured Party a lien and security interest in and to the Marks, all registrations and applications for registrations of the Marks, including the registrations and applications identified on Schedule I, together with the goodwill of the business symbolized by the Marks and together with all of Borrower's right to sue and recover for infringement of the Marks, free and clear of all liens, claims, charges, security interests, and other interests or encumbrances, which assignment and security interest shall secure the prompt payment and performance in full when due of the Secured Obligations, as set forth in the Security Agreement.

Borrower hereby acknowledges and affirms that the security interest granted in this Agreement is granted in conjunction with the security interest granted to the Secured Party under the Security Agreement and those rights and remedies of the Secured Party which are now or subsequently available to the Secured Party as a matter of law or equity.
