WHITTMANHART, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

FIRST: That the Board of Directors of the Corporation adopted the following resolutions at a special meeting of the Board of Directors, proposing and declaring advisable an amendment to the Second Amended and Restated Certificate of Incorporation of the Corporation (the "Certificate of Incorporation"), as amended, to change the name of the Corporation:

WHEREAS, this Board of Directors deems it advisable to change the name of the Corporation and to make all amendments to the Second Amended and Restated Certificate of Incorporation of the Corporation, as amended, as are necessary to effect such name change;

NOW THEREFORE BE IT RESOLVED, that the Second Amended and Restated Certificate of Incorporation of the Corporation is hereby amended by deleting Article I thereof and by substituting in lieu thereof the following:

Article I: The name of the Corporation is: "BAND DIGITAL INC."

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders of the Corporation having at least a majority of the votes entitled to be cast on this amendment have approved said amendment without a meeting by less than unanimous written consent, in accordance with the provisions of Section 228 of the General Corporation Law of Delaware.

THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Sections 141 and 242 of the General Corporation Law of the State of Delaware.
