ASSIGNMENT OF TRADEMARKS AND SERVICE MARKS

2. Further Assurances. Each Assignor agrees to execute and deliver such other documents and to take all such other actions which the Assignee, its successors, assigns and/or legal representatives may reasonably request to effect the terms of this Assignment, and to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens and other documentation as may be reasonably requested by Assignee to effect the terms of this Assignment and its recordation in relevant state and national trademark offices. Each Assignor also hereby irrevocably appoints Assignee as its attorney-in-fact coupled with an interest to act in Assignor's name, place and stead to execute, deliver and record any documents or instruments of assignment or otherwise required in any country in which the Marks or Trademark and Service Mark Registrations are issued, or in which Assignee desires to seek protection for the Marks or Trademark and Service Mark Registrations.

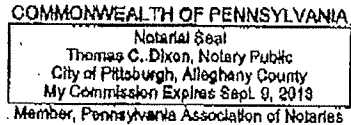
