**ARTICLES OF MERGER
 OF
 MARPAC CORPORATION
 WITH AND INTO
 SW ACQUISITION COMPANY, LLC**

Pursuant to Section 57C-9A-22(a) of the North Carolina General Statutes, SW Acquisition Company, LLC, a North Carolina limited liability company, does hereby submit these Articles of Merger as the surviving business entity in the merger of two business entities:
