ASSIGNMENT OF UNITED STATES TRADEMARK RIGHTS

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR has agreed to and does hereby assign to ASSIGNEE all right, title and interest to said TRADEMARK RIGHTS together with the goodwill of the business in connection with which the TRADEMARK RIGHTS are used and which is symbolized by the TRADEMARK RIGHTS, and the registrations thereof, *nunc pro tunc*, effective as of **January 2, 2005**.

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States to issue the TRADEMARK RIGHTS to ASSIGNEE in accordance with the terms of this instrument.
