**PATENT AND TRADEMARK RELEASE AND REASSIGNMENT**

THIS PATENT AND TRADEMARK RELEASE AND REASSIGNMENT is effective as of July 1, 2010, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Collateral Agent ("Wells Fargo").

WITNESSETH:

WHEREAS, Wells Fargo and *infoGROUP* Inc., formerly known as *infoUSA* Inc., a Delaware corporation ("*infoGROUP*"), are parties to that certain Security Agreement dated as of March 25, 2004 (the "Security Agreement"), pursuant to which *infoGROUP* granted a security interest to Wells Fargo in the Collateral (as defined in the Security Agreement) as security for certain obligations owing by *infoGROUP* to Wells Fargo, including, without limitation, the Patents (as defined in the Security Agreement) (and intellectual property relating to same) set forth on Exhibit A hereto and the Trademarks (as defined in the Security Agreement) (and intellectual property relating to same) set forth on Exhibit B hereto; and

WHEREAS, in conjunction with the security interest granted to Wells Fargo under the Security Agreement, Wells Fargo and *infoGROUP* entered into that certain Grant of Security Interest in United States Trademarks and Patents, dated as of March 25, 2004 (the "Grant of Security Interest"), pursuant to which *infoGROUP* granted a security interest in (i) all of *infoGROUP*'s rights, title, and interest in and to the United States patents and patent applications (the "Patents") as set forth on Exhibit A attached hereto, and (ii) all of *infoGROUP*'s right, title, and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Trademarks") set forth on Exhibit B attached hereto, in each case together with (iii) all proceeds and products of the Patents and Trademarks (as defined in the Grant of Security Interest), (iv) the goodwill of the business with which the Trademarks are associated, and (v) all causes of action arising prior to or after the date of the Grant of Security Interest for infringement of any of the Patents and Trademarks or unfair competition regarding the same and all damages awarded therefrom.

WHEREAS, the Grant of Security Interest, as applicable to the Trademarks, was recorded in the Assignment Division of the United States Patent and Trademark Office on April 9, 2004, at Reel 002826, Frame 0184; and

WHEREAS, *infoGROUP* has requested that Wells Fargo release its security interest in the Patent and Trademark Collateral subject to the Security Agreement and release the security interest granted pursuant to the Grant of Security Interest;
