WHEREAS, ASSIGNOR and ASSIGNEE have entered into a certain Contract for the Assignment of Intellectual Property Rights dated, December 4, 2009 assigning, among other things, all right, title and interest in and to the MARKS and in and to the registrations and/or applications for same from ASSIGNOR to ASSIGNEE;

NOW, THEREFORE, for good and valuable consideration paid by ASSIGNEE to ASSIGNOR, the receipt and sufficiency of which hereby is acknowledged, ASSIGNOR hereby sells, transfers, conveys, assigns and delivers to ASSIGNEE its entire right, title and interest in, to and under the MARKS, and to the applications and/or registrations for the MARKS (and the right to apply for the foregoing), together with the goodwill of the business symbolized by the MARKS and the portion of the business of the ASSIGNOR to which the MARKS pertain.

1. Assignor hereby assigns to Assignee all causes of action, claims and rights to damages or profits, due or accrued, arising out of past infringement of the MARKS, or injury to the goodwill associated with the MARKS.

2. Assignor represents and warrants that it will cooperate (i) in any actions necessary for Assignor to prosecute, renew or register its rights, title and interests in and to the MARKS, and (ii) in any actions brought to enforce the rights accompanying this Assignment against third parties.
