ASSIGNMENT OF TRADEMARK

WHEREAS, NORTHWEST MEDICAL PHYSICS, INC., a corporation organized and existing under the laws of the State of Iowa, and having an address of 102 1st Street South, Kalona, Iowa 52247, had adopted, had used and was the owner of the trademark ACCULOC, the goodwill of the business associated with and symbolized by said trademark, and Certificate of Registration No. 2,642,257, issued by the U.S. Patent and Trademark Office on October 29, 2002 for said trademark;

WHEREAS, MEDTEC, INC. wishes to reduce to writing said transfer and assignment.

NOW, THEREFORE, IN CONSIDERATION of the sum of One Dollar (\$1.00) and other good and valuable consideration, said NORTHWEST MEDICAL PHYSICS, INC. states that on or about December 4, 2009 it orally assigned and transferred to said MEDTEC, INC., and by these presents, does hereby assign and transfer to said


