**RELEASE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

Reference is made to that certain Intellectual Property Security Agreement (the "Security Agreement"), dated as of December 28, 2007, by and among each of the grantors listed on the signature pages thereto (the "Grantors") in favor of General Electric Capital Corporation, as agent (the "Agent") and recorded at (i) the United States Patent and Trademark Office at Reel 020309, Frame 0753 on January 3, 2008 and Reel 003688, Frame 0648 on January 3, 2008 and (ii) the United States Copyright Office at Volume 3560, Document Numbers 358 and 359 on January 17, 2008.

Pursuant to the Security Agreement the Grantors granted to the Agent a security interest in the Grantors' right, title, and interest in certain patents, trademarks and copyrights including those listed on Schedules I, II and III hereto (the "Intellectual Property").

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest in the Intellectual Property;


NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Intellectual Property pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this release, the Agent hereby states as follows:

The Agent hereby terminates, releases and discharges its security interest in the Intellectual Property, and re-assigns and releases to the Grantors all right, title and interest that the Agent has in and to the Intellectual Property and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including, without limitation, all goodwill associated in any way with such Intellectual Property; and all rights corresponding thereto associated with such Intellectual Property, without any representation, recourse or undertaking by Agent.

This release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
